दिल्ली हाईकोर्ट ने राष्ट्रीय पात्रता सह प्रवेश परीक्षा (नीट) 2019 के पुनर्मुल्यांकन की मांग वाली याचिका खारिज कर दी है। याचिका में कहा गया था कि परीक्षा में आए चार प्रश्नों के एक से ज्यादा सही जवाब थे, इसलिए पुनर्मुल्यांकन होना चाहिए।
न्यायमूर्ति जयंत नाथ की पीठ ने कहा कि पहली नजर में याचिकाकर्ता ऐसी कोई स्पष्ट गलती दिखाने में असफल रहे, जिससे कि हाईकोर्ट की यह पीठ अंतरिम आदेश जारी करे।

न्यायालय दी याचिका खारिज करती है। सवालों को हटा दिया जाए और इन सवालों को छोड़कर पुनर्मुल्यांकन किया जाए। इस सुझाव का विरोध करते हुए अधिकारियों ने कहा कि मौजूदा चरण में यह नहीं हो सकता, क्योंकि इससे देश की समूची मेधा सूची में बदलाव करना होगा। नीट 2019 के 5 जून को घोषित परिणाम को खारिज करने वाली याचिका पर अदालत ने केंद्र, एनटीए और भारतीय चिकित्सा परिषद के जवाब मांगे थे। अगली सुनवाई 4 जुलाई को होगी।
