Details of pending Indirect Tax Litigations as on 28.07.2023, the outcome of which may have an impact on the company:

<p>1. Classification dispute of Naphtha</p> <p><u>Opposing party:</u> Central Excise Department</p> <p><u>Brief details of dispute/litigation:</u> Central Excise Department had issued Show Cause Notice alleging that ‘Naphtha’ manufactured by LPG plants the Company is ‘Natural Gasoline Liquid (NGL)’ and attracted additional excise duty of ₹ 15/- per litre in addition to ad valorem excise duty. Initially, the SCNs were dropped by the Commissioner, Central Excise vide order dated 23.07.2014. However, CESTAT Delhi vide order dated 30.11.2018 confirmed the demand of differential Central Excise duty. The company has filed an appeal before the Hon’ble Supreme Court. The appeal filed by company was admitted and stay was granted on 08.04.2019 by the Hon’ble Court on deposit of ₹ 20 crore & bank guarantee of ₹ 132 crore submitted to department.</p> <p><u>Current Status:</u> Pending before Hon’ble Supreme Court for Final Hearing.</p> <p><u>Expected Financial Implication as on 28.07.2023:</u> ₹ 3494 Crore.</p>
<p>2. Demand of duty on LNG claimed as transit loss and LNG supplied for Power generation</p> <p><u>Opposing party:</u> Custom Department</p> <p><u>Brief details of dispute/litigation:</u> Company has availed benefit of exemption of Custom Duty on import of LNG which was supplied to power generating companies. Customs Department had issued Show Cause Notice to the company, denying the benefit of exemption availed on the ground that utilization certificates were not produced within time limit as specified in exemption notification. Further, benefit of exemption of Custom Duty on LNG claimed as transit/process loss (0.66%) was also denied and corresponding demand on that account was also raised. Commissioner, Customs vide order dated 20.01.2022 confirmed the demand of ₹ 203 crores with equal amount of penalty and applicable interest. The company has challenged the order dated 20.01.2022 before Hon’ble Gujarat High Court. The writ petition filed by company was admitted and stay was granted on 21.04.2022 by the Hon’ble Court on deposit of ₹ 10 crores.</p> <p><u>Current Status:</u> Pending before Hon’ble Gujarat High Court for Final Hearing.</p> <p><u>Expected Financial Implication as on 28.07.2023:</u> ₹ 637 Crore.</p>
<p>3. Demand of Special Additional Duty (SAD) on import of LNG at Dabhol Port</p> <p><u>Opposing party:</u> Custom Department</p>

Brief details of dispute/litigation: Customs Authority, Dapoli vide orders dated 29.03.2023 had confirmed demand of ₹ 934.01 crore including penalty and interest, on account of Special Additional Duty (SAD) and Custom Duty on differential quantity, while finalizing provisionally assessed Bill of Entries in respect of import of LNG by Company during Sept'2017 to Mar'2022 at Dabhol Port, Ratnagiri. Considering the merits of the case, the Company has filed an appeal before the Commissioner (Appeals) Pune. Meanwhile, Central Board of Indirect Taxes and Customs (CBIC) issued clarification on 19.05.2023 clarifying that SAD is exempt on import of LNG. Thus, considering the clarification dated 19.05.2023 and practice being followed at other Custom Ports i.e. Dahej & Hazira, the Company is confident of favorable outcome in the matter.

Current Status: Pending before Commissioner (Appeals) Pune for adjudication.

Expected Financial Implication as on 28.07.2023: ₹ 969 Crore.

4. Demand of GST @ 18% instead of @ 5% on supply of Domestic LPG from 01.07.2017 to 24.01.2018

Opposing party: GST Department

Brief details of dispute/litigation: GST Authorities at Gandhar (Gujarat) and Vijaipur (MP) issued a Show Cause Notice, demanding differential GST of ₹173 Cr. considering the rate of 18% on LPG supplied to Oil Marketing Companies (OMCs) instead on 5% as charged and paid by Company during 01.07.2017 to 24.01.2018. The SCNs was issued on the ground that Company is not eligible for the benefit of concessional rate of 5% on LPG supplied to OMCs and tax shall be levied @ 18%. The Company has filed Writ Petition before the Hon'ble High Court of Gujarat and MP. Both the writ petitions were admitted and stay in matter was granted by Hon'ble High Court of Gujarat and MP on 30.04.2019 and 30.07.2021 respectively.

Current Status: Pending before Hon'ble High Court of Gujarat & MP for Final Hearing.

Expected Financial Implication as on 28.07.2023: ₹ 532 Crore.
