बिहार और यूपी के लोग पैर-संक्रमण बीमारीयें सुपेडिटीज और हाइपरटेंशन को चपेट में चुने तरह आ रहे हैं। केंद्र, डायबिटीज, हृदय रोग और स्ट्रोक से बचने के लिए सुधार राष्ट्रीय कार्यक्रम (एनसीडी स्क्रीनिंग) के तहत मरीजों को स्क्रीनिंग के आंकड़ों से तहत मरीजों काता खुलासा हुआ है।

आंकड़ों के मुताबिक, स्क्रीनिंग में बिहार के 30 फीसदी से अधिक लोगों में डायबिटीज की बीमारी पाई गई, वहीं यूपी में साढ़ तेरह फीसदी लोग डायबिटीज से पीड़ित थे। सुधार को केंद्रीय स्वास्थ्य एवं परिवार कल्याण मंत्री डॉ. हर्षचंधन द्वारा जारी डेनरल हेल्थ प्रोमोशन-2019 में यह आंकड़े प्रकाशित हैं।

शिवसेना के पास तीन फार्मूले हैं। एक, उसका मुख्यमंत्री बने जो संभव नहीं है और माना जा रहा है कि इस बात को भाजपा चुनाव से पहले ही अस्वीकार कर चुकी है। सत्ता में बराबर की हिस्सेदारी की जो बात गठबंधन से पूर्व प्रेस कॉन्फ्रेंस में की गई थी, उसके अलग-अलग मतलब निकाले जा रहे हैं।

शिवसेना के अनुसार, इसका मतलब यह है कि ढाई-ढाई साल के लिए दोनों के मुख्यमंत्री हों। मगर, भाजपा साफ कर चुकी है कि सत्ता में बराबरी का मतलब मुख्यमंत्री पद में हिस्सेदारी नहीं है। बहरहाल, शिवसेना को उप मुख्यमंत्री के पद का प्रस्ताव

देकर भाजपा ने इस फार्मूले को भी खारिज कर दिया है।

मौजूदा परिस्थितियों में शिवसेना के पास एक ही विकल्प बचा है कि वह उप मुख्यमंत्री का पद लेने के साथ ही ज्यादा मंत्री पद और अहम मंत्रालय हासिल कर ले। इससे जहां वह सरकार में मजबूत होगी, वहीं सूबे में उसका रुतबा भी बढ़ेगा।

वित्त, राजस्व, गृह व शहरी विकास जैसे अहम मंत्रालय यदि शिवसेना को मिलते हैं और वह 15-18 मंत्री पद हासिल करती है तो उसका सरकार पर दबदबा रहेगा। यह माना जा रहा है कि भाजपा अपने सहयोगी शिवसेना को खोएगी नहीं, इसलिए कुछ मांगें स्वीकार कर बीच का रास्ता निकाला जा सकता है।

short stories NPCIL CONFIRMS BREACH IN KUDANKULAM PLANT NETWORK

NEW DELHI: The Tamil Nadu-based Kudankulam power plant was the target of a cyberattack, the Nuclear Power Corporation of India Limited (NPCIL) said on Wednesday, a day after it reported about the hacking. The cyber-attack was able to compromise the network that is used for 'administrative' use and is not connected to the running of the nuclear power plant. The NPCIL also said that subsequent investigations confirmed the plant's core control system was 'not affected'.

NIRAV MODI SEeks BAIL IN LONDON COURT AGAIN

LONDON: Diamantare Nirav Modi, sought in India to face charges of major financial offences linked to the Anghel National Bank, has once again applied for bail in the Westminster Magistrates Court, officials said Wednesday. Modi has been lodged in the Wandsworth jail in west London since March. The latest bail is likely to be based on medical grounds. He has previously been ordered bail three times in the magistrates court. Modi's lawyer has previously expressed his stay in the overcrowded jail as 'extreme' and 'personally offensive'.

HOODA, VORA GET INTERIM BAIL IN AJL LAND CASE

CHANDIGARH: Former Haryana chief minister Bhupinder Singh Hooda and Congress leader Mohit Vora were on Wednesday granted interim bail by a special Enforcement Directorate court in Andhra in the Associated Journals Limited land allotment case. While granting interim bail to the two Congress leaders, Special Judge Jagdeep Singh also issued notice to the agency regarding its stance on the regular bail pleas in the case, said an advocate representing Hooda. He said the court fixed November 6 as the next date to hear the bail pleas of two leaders, who were granted interim bail on a surety of ₹1 lakh each. The ED has in August 2019 filed its first charge sheet implicating leaders Vora and Hooda in the case of alleged land allotment irregularities to AJL.

ODISHA GOVT ORDERS PROBE AFTER SURGEY TRIGGERS HIV SCARE

BHUBANESWAR: The Odisha government on Wednesday ordered a probe into allegations that a dental surgeon at a government medical college-hospital Sambalpur district had exposed two patients to the risk of HIV infection as he did not follow the necessary sterilisation protocol after operating on an HIV patient. However, the doctor Prashant Swain, has denied any negligence, and claimed it was a conspiracy to frame him. The probe had been ordered after Swain had purportedly exposed two patients immediately after he had performed a surgery on an HIV patient on October 28, 'without taking the necessary precautions'.

'Relationship between judges better than before'

HT INTERVIEW SHARAD ARVIND BOBBE, next CJI

Bhadra Sinha @bhadrasinha on Twitter: In November 18, Justice Sharad Arvind Bobde, who will be sworn in as the 17th Chief Justice of India, a day after the incumbent CJI Ranjan Gogoi retires from office. Justice Bobde has been part of benches that have delivered landmark judgements that the law will remain bereft for the role he played in defusing tensions between the then CJI Dipak Misra and four judges, including present CJI Gogoi, who held a press conference on January 12, 2018 to air their grievances about how the top court was being run.

The press conference called by the four judges on January 12 exposed the institution's vulnerability. Questions were raised over the lack of collective leadership in the top court. How will you ensure this issue is dealt with under your expected tenure? You play a key role in resolving the differences back then?

The press conference was very disturbing for all of us. It was disturbing to see that things in Supreme Court had come to such a pass. I looked upon all the judges as one court, and I knew people on what were being called the two sides. I did what came to me naturally. Some hard lines were drawn by people among themselves. That made the situation very difficult. A lot of conflict in institutions arises when there is a conflict between right and right. Nobody deliberately acts in the consciousness that he is wrong. People are right when they are right when taking a stand. This has to be collegiality, otherwise all the collegiality together can never function as a court. Today the situation is very different from that period. It's not the same. Relationship between judges is much better than ever before. Judges often interact with each other informally; there is no communication gap between the judges now. I consider all the judges as one and they represent the Supreme Court together.

The judiciary has been facing criticism over the opaque system of appointing judges to the high court and Supreme Court. Last year, the apex court's collegium took a decision to upload its resolutions on the website, giving reasons for not elevating a particular lawyer as a judge. It seems the present collegium, which includes you, has gone back on that decision. Why?

With social media becoming more aggressive, the judiciary is under constant scrutiny. What is your opinion on this growing trend where every decision taken by the judiciary, including composition of benches, is being judged by the public?

New cyclone could bring rain to south

KERALA, LAKSHADWEEP, COASTAL ANDHRA, TELANGANA AND TAMIL NADU WILL RECEIVE MODERATE TO VERY HEAVY RAINFALL AS A RESULT OF THE CYCLONE

NEW DELHI: A new cyclone is developing over the Arabian Sea, which will coexist with cyclonic storm Kyarr that has now weakened into the 'very severe' category from the earlier 'extremely severe' level, according to the India Meteorological Department (IMD).

The new cyclonic storm in Arabian Sea has been named 'Maha' (pronounced as M-mah). One formed in the fourth cyclone in Arabian Sea this year after Vayu, Hikka and Kyarr. It is probably the first time ever that the Arabian Sea has been this active but data hasn't been verified yet. IMD

Kerala, Lakshadweep, coastal Karnataka, coastal Andhra Pradesh, Telangana and Tamil Nadu will receive moderate to very heavy rainfall under the influence of Cyclone Kyarr. A well-marked low pressure area had formed over Comorin Area, and adjoining Equatorial Indian Ocean, which had concentrated into a depression on

Wednesday. IMD on Wednesday evening said the depression was very likely to move north-westwards across Lakshadweep Islands during the next 24 hours, and into a cyclonic storm during the subsequent 36 hours.

Scientists said higher sea surface temperature can be a factor but they did not attribute it directly to climate change. The cyclone will cross the Indian coast, its moving towards Oman. There is likely to be rainfall in peninsular India under its influence, said M Mohapatra, director general of meteorology, IMD.

Chief justices of 3 high courts shifted

NEW DELHI: Chief Justices of three high courts in India were shifted on Wednesday. Justice Anil Kumar Mital, who is heading the Meghalaya HC, has been transferred to the Madhya Pradesh HC. Justice Sanjay Yadav is officiating as the chief justice of the MP HC after Justice Ravi Shankar Jha, who was also an acting chief justice, was elevated as Chief Justice of the Punjab and Haryana HC. Justice Rakesh Kumar, a judge of the Andhra Pradesh HC, has been sent to the Kerala HC.
