1.0 Introduction

GAIL (India) Limited (“GAIL”) owns and operates an integrated petrochemical complex with Poly-Ethylene (PE) production facilities at Pata which produces PE pellets of various grades suitable for downstream plastic processing applications at Pata, District - Auraiya, UP (approx. 120 kms from Kanpur).

GAIL also owns land parcels in a proximity of approximately 6 km to the petrochemical complex. It is envisaged to promote the development of downstream plastic processing industries, specifically units for manufacturing raffia bags & related woven products on these available land parcels utilizing PE grades from GAIL’s co-located petrochemical plant.

Accordingly, GAIL invites Expressions of Interest (“EOI”) from eligible and interested parties (“Parties”) for setting up raffia bag manufacturing units near the integrated petrochemical complex.

2.0 Objective of the Expression of Interest (Eoi)

The objective of this EOI is to:

- (i) Assess market interest for setting up raffia bag manufacturing units in the vicinity of GAIL’s petrochemical complex at Pata
- (ii) Obtain indicative information on technical, land, utility and investment requirements
- (iii) Understand potential configuration and implementation timelines of proposed units
- (iv) Facilitate further discussions with shortlisted Parties for possible allotment of land and long-term business association, including feedstock linkage

This EOI does not constitute an offer or commitment of any kind by GAIL.

3.0 Expression of Interest (EOI)

Parties are expected to set up independent manufacturing facilities for raffia bags and other woven polyethylene products using PE pellets as primary raw material. Proximity to the petrochemical complex is expected to provide logistical and supply-chain advantages.
