

### GAIL (India) Limited

With a turnover of US \$ 8.9 billion approx. (INR 56,742 crore) GAIL (India) Limited is India's largest natural gas company and ranked among the top gas utilities in Asia. Our business activities range from Gas Transmission and Marketing to Processing (for fractionating LPG, Propane, SBP Solvent and Pentane); transmission of Liquefied Petroleum Gas (LPG); production and marketing of Petrochemicals like HDPE and LLDPE. We have extended our presence in Liquefied Natural Gas (LNG) re-gasification, City Gas Distribution and Exploration & Production through equity and joint venture participations. Of late, we have also diversified into solar and wind power regeneration.

With a lean but efficient work force of about 4,000 employees, we play a meaningful role in the social and economic development of the country and make a substantial contribution towards its energy security. As recognition of our potential to emerge as a global player and the significant role we have played in the country's economic development, we have been endowed the status of Maharatna (Most Precious Jewel) by the Government of India, the youngest Public Sector Undertaking to have been awarded this honour.





### **Global Forays**

As part of our growth strategy and in pursuance of long term business goals, we have set up a wholly owned subsidiary company, viz., GAIL Global (Singapore) Pte. Ltd. in Singapore for sourcing and sale of LNG, LNG and petrochemicals trading and overseas investments. A wholly owned subsidiary, GAIL Global (USA) Inc. has been established in USA for acquiring 20% working interest with Carrizo Oil & Gas Inc. in the Eagle Ford shale acreage in the state of Texas, USA. Further, GAIL Global (USA) LNG LCC, a wholly owned subsidiary of GAIL Global (USA) Inc. has also been formed to explore LNG import/liquefaction capacity booking opportunities from USA.

We have signed long term LNG supply contracts for 3.5 MMTPA with Sabine Pass Liquefaction LLC, USA, 2.3 MMTPA with Dominion Cove Point LNG, USA and 2.5 MMTPA with Gazprom Shtokman LNG project, the supplies from which are expected to commence from 2018-2020. GAIL has signed around 30 Master Sales Purchase Agreements with all reputed LNG suppliers including BG, SHELL, Total, etc. under which we have been importing LNG cargoes from time to time. In addition, GAIL is importingLNG under term deals signed from time to time with various suppliers.

We are part of a leading consortium in two offshore E&P blocks in Myanmar and hold participating interest in the joint venture company–South East Asia Gas Pipeline Company Limited, incorporated for transportation of gas produced from two blocks in Myanmar to China. GAIL has also signed an agreement with Turkmengaz for purchase of 38 MMSCMD gas to be transported through transnational Turkmenistan-Afghanistan–Pakistan-India (TAPI) Pipeline.

We are equity partners in two retail gas companies in Egypt, viz., Fayum Gas Company (FGC) and National Gas Company (Natgas) and one retail gas company in China, viz., China Gas Holdings Limited.

We are pursuing business opportunities in emerging markets in different geographies such as USA, East Africa, South / South-East Asia and West Asia in the areas of exploration and production, LNG, petrochemicals, gas processing & transmission and CNG & city gas distribution.


## Sustainability & Social Investments
